- 1.3 If you sign up for any Connexin Rural Broadband (Connexin Wireless) package during this period the following promotion(s) will be applied:**

24-Month Contracts:

- 1.3.1 Essential: Wireless 150 (150Mbps) – £9.99 for 24 months. This price will remain fixed throughout the contract's lifetime. Upon contract expiration, the standard rate of £39.99 will apply unless you choose to renew under alternative offers available at that time.**
- 1.3.2 Plus: Wireless500 (500Mbps) – £14.99 for 24 months. This price will remain fixed throughout the contract's lifetime. Upon contract expiration, the standard rate of £49.99 will apply unless you choose to renew under alternative offers available at that time.**



- 1.3.3 Premium: Wireless 1000 (1000Mbps) – £19.99 for 24 months. This price will remain fixed throughout the contract's lifetime. Upon contract expiration, the standard rate of £54.99 will apply unless you choose to renew under alternative offers available at that time.

- 1.11** For home vouchers of up to £1,500 (including VAT), the installation fee is fully covered by the Gigabit Broadband Voucher Scheme.
- 1.12** For SMEs, the installation fee of up to £3,500 (excluding VAT) is covered by the Gigabit Broadband Voucher Scheme (up to £700 of VAT will be paid by the business customer upon completion of the installation). Installation is subject to site survey and may incur additional excess construction charges.
- 1.13** A minimum contract term applies unless otherwise stated.
- 1.14** The external radio equipment will remain the property of Connexin during the contract and must be returned to us in full working order and in a good condition should you terminate your service with Connexin.
- 1.15** Connexin reserves the right to charge full price for radio equipment delivered under this contract if invoices are not paid on a timely basis, if the contract is terminated prior to the expiry of the minimum contract term, or if the radio equipment is damaged. 2 GUARANTEED WI-FI PROMOTIONAL TERMS

- 2.1 Connexin Guaranteed Wi-Fi provides up to three mesh units to ensure a reliable Wi-Fi connection in every room of your home. This guarantee does not cover broadband faults. For full details, please refer to our Standard Terms & Conditions.**
- 2.2 Available to all customers who purchase Connexin Rural Broadband, City Fibre network or Connexin Wireless from 16th June 2025.**
- 2.3 Customers will receive a router suitable for their chosen speed package and up to three mesh units to ensure full Wi-Fi coverage throughout their home.**
- 2.4 All routers and mesh units remain the property of Connexin and are provided for use as part of the broadband service. If the service is cancelled or the agreement is terminated, all equipment must be returned as outlined in our Standard Terms & Conditions.**
- 2.5 Upon installation, Connexin engineers will position the router in the optimal location and provide up to three mesh units to ensure a stable Wi-Fi connection throughout the home.**
- 2.6 Wi-Fi signal strength can be tested via the Connexin Smart Home App by navigating to the "My Network" section and running a "Bandwidth Test."**
